# AAC Assessment & Implementation Certificate Course

**Description:** AAC Assessment & Implementation is a virtual course that prepares participants to assess students with complex communication needs who may benefit from augmentative and alternative communication (AAC). The course will provide content in multiple synchronous class sessions and coaching through the assessment process for all participants. Participants will be required to complete one AAC assessment on a student of their choice, where feedback will be provided. A completed assessment must adhere to the class-provided AAC assessment report template requirements to pass the course. Upon completion of the report, participants will receive a certificate of completion for 45 hours. Students can earn 3.0 Graduate Level PDUs through the University of Massachusetts Global for a separate additional cost. (*This course does not cover assistive technology.*)

Participants will demonstrate skills and knowledge in the following areas: knowledge of the AAC Assessment Framework, identifying and using AAC assessment tools, interpreting results from using assessment tools, identifying AAC devices (low or high tech) to use in device trials during the assessment process, analyzing data results from assessment trials, providing sound recommendations for AAC, writing, legally defensible AAC reports, understanding and writing IEP goals, using progress monitoring and data collection methods, knowledge of AAC applications, AAC devices including eye gaze and switches, how to implement AAC, and how to recommend and provide training for AAC.
